- C. Matthew Cox, Environmental Specialist III, Office of Agricultural Water Policy-Florida Department of Agriculture and Consumer Services (OAWP-FDACS) Report:
  - ❖ FDACS, via CRI has sent out 990 letters to landowners in the IRL BMAP areas. Those 990 landowners account for 2,126 parcels within the IRL BMAP area. Responses from the letters have come in for 617 parcels. 467 of those parcels have been assigned to staff for enrollment. So far, staff have enrolled 98 parcels.
  - Of the 617 parcels we have received responses for, 590 want to enroll, 11 inquired about WQ monitoring, 12 have been identified as Not Ag, 1 has been sold, and 3 are silviculture.
  - Field staff continue to conduct implementation verifications for enrolled producers on or prior to their individual due dates in BMAP's as well as completing cost share projects that are currently ongoing.
